In recent years, Bausano S.p.A. has developed an Integrated Policy "Quality, Health and Safety at Work and the Environment" (hereinafter "Integrated Policy") to guide its business decisions and make a concrete commitment to responsible management of its business. To demonstrate this commitment, the company has decided to implement the Quality Management System with the Health and Safety Management System and finally with the Environmental Management System it has decided to pursue their **continuous improvement** in accordance with the requirements of the international standards **ISO 9001**, **ISO 45001** and **ISO 14001**.

Bausano S.p.A. also adopted, at the end of 2024, the Organisational Management and Control Model pursuant to Legislative Decree no. 231/01, considering it a fundamental tool for ensuring compliance with ethical principles and legislative compliance in the performance of its activities.

This Integrated Policy defines the main objectives that the Company undertakes to achieve in the management of the three thematic areas.

In QUALITY management, Bausano S.p.A. pursues the following objectives:

- Responding to the needs of the market, offering products that comply with the required specifications, paying the utmost attention and professionalism in all phases of the project order: technical assistance at the time of signing the contract, search for the best solution, design, purchasing, production, shipping and after-sales services.
